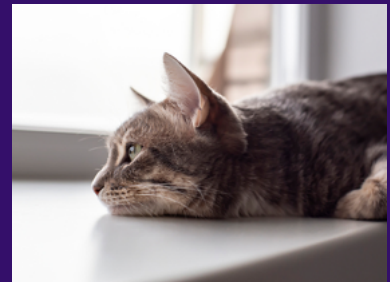
NEW LAWS - EFFECTIVE OCT. 1, 2023

PUBLIC ACT 23-138. MUNICIPAL ANIMAL SHELTERS

- Indoor temperatures of municipal animal shelters must be kept between 55 and 80 degrees.
- City Executives must be notified of shelter violations.



PUBLIC ACT 23-149. CRUELTY TO ANIMALS



- Defines bestiality as "sexual assault" of an animal which makes it eligible for the sex offender's registry.
- Bans a person convicted of animal cruelty from harboring, owning, possessing, residing with, adopting, or serving as a foster placement for any animal and he/she shall not be employed by or volunteer for any entity in any position that involves care for or regular contact with any animal.
- Requires veterinarians to report a person suspected of harming, neglecting or treating cruelly an animal due to participation in animal fighting to the local law enforcement agency or animal control officer.

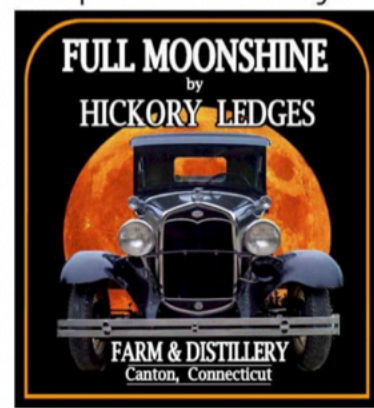

8/1/2023 • **Remer Glenn Martin** • Sentenced to 364 Days Jail, Execution Suspended, Probation 2 Years

8/3/2023 • **Christina Cliff-Lataif** • Sentenced to 6 Months Jail, Execution Suspended, Conditional Discharge 1 Year

8/15/2023 • **Glorianne Lagnese** • Sentenced to 364 Days Jail, Execution Suspended, Probation 3 Years

8/17/2023 • **James Llanos** • Sentenced to 364 Days Jail, Execution Suspended, probation 3 Years

8/18/2023 • **Christopher Vantull** • Sentenced to 44 months, execution suspended after serving 6 months and 3 years probation.
